Currently, 61.3% of the 43,593 housing units in the area are owner occupied; 34.2%, renter occupied; and 4.5% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.3% are renter occupied; and 11.3% are vacant. In 2010, there were 42,963 housing units in the area - 63.9% owner occupied, 31.2% renter occupied, and 4.9% vacant. The annual rate of change in housing units since 2010 is 0.65%. Median home value in the area is \$291,430, compared to a median home value of \$177,257 for the U.S. In five years, median value is projected to change by 4.24% annually to \$358,666.
